The President, Dr. Subhash Chavda Ahir Kelavani Mandal, Junagadh-362001 has applied for establishment of Dr. Subhash Ayurveda Research Institute, Dr.Subhash Road, Near Khamdhrol Railway Crossing,Junagadh-362001. After careful consideration of the proposal, the Government of Gujarat has decided to issue "**No Objection Certificate**" to the applicant for establishment of Ayurvedic College with 60 (Sixty) seats capacity for starting B.A.M.S Course for the academic year 2024-25.

It is certified that:

1. The applicant owns and manages a 60 beds hospital, which was established in January, 2018.
2. It is desirable to establish Ayurveda College in public interest with admission capacity of 60 (Sixty) seats for B.A.M.S. Course.
3. Establishment of Ayurveda College with admission capacity of 60 (Sixty) seats for B.A.M.S. Course at Dr. Subhash Ayurveda Research Institute, Dr.Subhash Road, Near Khamdhrol Railway Crossing,Junagadh-362001 is feasible.

This No Objection Certificate is issued subject to following conditions:-

1. The college must appoint required regular staff and construct necessary infrastructure before the inspection of N.C.I.S.M. as per the norms of N.C.I.S.M, MSR-2016. An Undertaking in this regard must be given by Dr. Subhash Ayurveda Research Institute, Dr.Subhash Road, Near Khamdhrol Railway Crossing, Junagadh-362001 to the Department of Health and Family Welfare, Sachivalaya, Gandhinagar, Government of Gujarat.
2. The college has to run the course on Self Finance basis and college will not ask for Grant in Aid in future. An Undertaking for this condition must be obtained by Director, AYUSH, Gandhingar from Dr. Subhash Ayurveda Research Institute, Dr.Subhash Road, Near Khamdhrol Railway Crossing, Junagadh-362001.
3. The college must follow admission Rules and Regulation as well as fee structure as decided by the Government of Gujarat from time to time.
4. The College has to follow the Rules and Regulations prescribed by the affiliating University and National Commission for Indian System of Medicine, New Delhi from time to time.
5. The College must fulfill the norms of minimum standards prescribed by N.C.I.S.M., New Delhi from time to time.

It is also certified that adequate clinical material as per norms of the National Commission for Indian System of Medicine is available with the proposed Medical College. It is further certified that in case the applicant fails to create infrastructure for the Ayurveda College as per National Commission for Indian System of Medicine norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the student already admitted in the College with the permission of the Central Government.
